3 **PARTIES**

4
5 1. Plaintiff Methodist Hospital of Southern California ("Methodist
6 Hospital") is a non-profit public benefit corporation organized and existing
7 pursuant to the laws of the State of California. Methodist Hospital has its principal
8 place of operation in the City of Arcadia, County of Los Angeles, State of
9 California. Methodist Hospital provides medical care to patients.

10
11 2. Defendant Kaiser Foundation Health Plan, Inc. ("KFHP") is a
12 non-profit public benefit corporation organized and existing pursuant to the laws of
13 the state of California. KFHP has its principal place of business in the City of
14 Oakland, County of Alameda, State of California. Among other things, KFHP
15 contracts with individuals and groups to provide or arrange comprehensive prepaid
16 health care benefits.

17
18 3. Defendant Kaiser Foundation Hospitals ("KFH") is a non-profit
19 public benefit corporation organized and existing pursuant to the laws of the state
20 of California. KFH has its principal place of business in the City of Oakland,
21 County of Alameda, State of California. KFH owns and operates community
22 hospitals and contracts with KFHP to provide or arrange hospital services for
23 health plan members.

24
25 4. Defendant Kaiser Permanente Insurance Company ("KPIC") is
26 a for-profit corporation organized and existing pursuant to the laws of the state of
27 California. KPIC has its principal place of business in the City of Oakland, County
28 of Alameda, State of California. KPIC is in the business of managing and/or

1 paying for the healthcare services of its members.
2

3 5. Methodist Hospital is unaware of the true names and capacities,
4 whether corporate, associate, individual, partnership or otherwise of defendants
5 Does 1 through 25, inclusive, and therefore sues such defendants by such fictitious
6 names. Methodist Hospital will seek leave of the Court to amend this complaint to
7 allege their true names and capacities when ascertained.
8

9 6. KFHP, KFH, KPIC and Does 1 through 25, inclusive, shall be
10 collectively referred to as "Kaiser."
11

12 7. Defendants, and each of them, at all relevant times, have
13 transacted business in the State of California. The violations alleged within this
14 complaint have been and are being carried out in the County of Los Angeles, State
15 of California.
16

17 8. At all relevant times each of the defendants, including the
18 defendants named "Doe," was and is the agent, employee, employer, joint
19 venturer, representative, alter ego, subsidiary, and/or partner of one or more of the
20 other defendants, and was, in performing the acts complained of herein, acting
21 within the scope of such agency, employment, joint venture, or partnership
22 authority, and/or is in some other way responsible for the acts of one or more of the
23 other defendants.
24

25 **COMMON FACTUAL BACKGROUND**
26

27 9. Methodist Hospital is informed and believes and thereon
28 alleges that at all relevant times the patients identified on the spreadsheet attached

1 as Exhibit A to this complaint (and which is incorporated here by this reference as
2 through set forth in full) (collectively, "Patients") were members of a health plan
3 sponsored, administered and/or financed by Kaiser.
4

5 10. Methodist Hospital is informed and believes and thereon
6 alleges that at all relevant times, Kaiser provided, arranged, and/or paid for
7 healthcare services for its members, including the Patients set forth in Exhibit A.
8

9 11. The Patients were admitted to Methodist Hospital for medically
10 necessary treatment and services during the various dates of service set forth in
11 Exhibit A.
12

13 12. On the various dates of service set forth in Exhibit A, Methodist
14 Hospital provided medically necessary services, supplies and/or equipment to the
15 Patients, until each Patient became stable for discharge from Methodist Hospital.
16

17 13. Methodist Hospital's usual and customary charges for the
18 medically necessary services, supplies and/or equipment rendered to the Patients
19 amounted to \$2,625,703.55.
20

21 14. After discharging the Patients from Methodist Hospital,
22 Methodist Hospital timely and properly billed Kaiser for the medically necessary
23 services, supplies and/or equipment provided to the Patients. For the medical care
24 Methodist Hospital rendered to the Patients, it expected a total reimbursement of
25 \$2,625,703.55.
26

27 15. Rather than properly paying Methodist Hospital for the
28 medically necessary services, supplies and/or equipment Methodist Hospital

1 rendered to the Patients, within the past two years, Kaiser paid \$891,374.81,
2 leaving a balance of a sum to be proven at trial but not less than \$874,811.35,
3 exclusive of interest.

4
5 16. As a result of Kaiser's refusal to properly pay Methodist
6 Hospital for the medically necessary services, supplies and/or equipment rendered
7 to the Patients, Methodist Hospital has been damaged in a sum to be proven at trial
8 but not less than \$874,811.35, exclusive of interest.

9
10 **FIRST CAUSE OF ACTION**

11 (*Quantum Meruit*)

12 (Against defendant Kaiser)

13 (and/or including Does 1 through 25, inclusive)

14
15 17. Methodist Hospital incorporates by reference and re-alleges
16 paragraphs 1 through 16 here as though set forth in full.

17
18 18. On the dates of service set forth in Exhibit A, Methodist
19 Hospital provided medically necessary care to the Patients identified in Exhibit A.

20
21 19. By its words and/or conduct, Kaiser requested that Methodist
22 Hospital provide the Patients with medically necessary treatment and services.

23
24 20. Acting pursuant to Kaiser's implied and/or express request,
25 Methodist Hospital provided the Patients with medically necessary care.

26
27 21. Methodist Hospital's rendering of medical care to Kaiser's
28 members - *i.e.*, the Patients - was intended to, and did, benefit the Patients and

1 therefore Kaiser.

2

3 22. When providing the Patients with medically necessary care,
4 Methodist Hospital reasonably believed it would be fully compensated by Kaiser.

5

6 23. The usual and customary value of the medical care Methodist
7 Hospital rendered to the Patients was \$2,625,703.55.

8

9 24. Within the last two years, Methodist Hospital requested Kaiser
10 to pay for the medically necessary services, supplies and/or equipment Methodist
11 Hospital rendered to the Patients but Kaiser failed to properly pay Methodist
12 Hospital, paying \$891,374.81.

13

14 25. As a direct and proximate result of Kaiser's misconduct, Kaiser
15 damaged Methodist Hospital by not properly paying Methodist Hospital the usual
16 and customary value of the medically necessary services, supplies and/or
17 equipment Methodist Hospital rendered to the Patients in a sum to be proven at
18 trial but not less than \$874,811.35, exclusive of interest.

19

20 **SECOND CAUSE OF ACTION**

21 (Violation of California Health & Safety Code § 1371.4)

22 (Against Defendant Kaiser)

23 (and/or including Does 1 through 25, inclusive)

24

25 26. Methodist Hospital incorporates by reference and re-alleges
26 paragraphs 1 through 16 as though set forth in full.

27

28 27. Methodist Hospital is informed and believes and thereon

1 alleges that at all relevant times the patients identified on the spreadsheet attached
2 as Exhibit B to this complaint (and which is incorporated here by this reference as
3 through set forth in full) (collectively, "Emergent Patients") were members of a
4 health plan sponsored, administered and/or financed by Kaiser.

5
6 28. On the dates of service set forth in Exhibit B, the Emergent
7 Patients were admitted into Methodist Hospital for emergency services and care.
8 Methodist Hospital provided medically necessary, emergency medical care to the
9 Emergent Patients from the time of their admission, as set forth in Exhibit B, to the
10 time when each patient's condition had sufficiently stabilized to enable the patient
11 to be discharged.

12
13 29. The usual and customary charges for the medically necessary,
14 emergency services, supplies and/or equipment rendered to the Emergent Patients
15 was \$2,420,371.66, which Methodist Hospital submitted to Kaiser. Methodist
16 Hospital expected reimbursement of its usual and customary charges in the amount
17 of \$2,420,371.66.

18
19 30. California Health & Safety Code § 1371.4(b) provides, in
20 pertinent part: "A health care service plan shall reimburse providers for emergency
21 services and care provided to its enrollees."

22
23 31. Kaiser violated California Health and Safety Code § 1371.4 by,
24 within the last three years, failing to properly reimburse Methodist Hospital for the
25 emergency medical care provided to the Emergent Patients. Instead of properly
26 reimbursing Methodist Hospital, Kaiser paid \$848,033.47, leaving a balance of a
27 sum to be proven at trial but not less than \$810,265.70, exclusive of interest.


